

This Sports entry fee for Boys and Girls team shall be deposited separately. Further you are required to submit the Certificate of eligibility in case of each participant, Willingness Certificate by the Coach / Manager and consent /proposal of the Principal to host Zonal , Final and Selection trail on any Sports/Games /Events / Tournaments ,etc to the Council in the prescribed enclosed format along with the Computer generated e-Receipt in support of deposit of fees by 12.10.2018 addressed to the " Deputy Secretary, CHSE (O), Bhubaneswar-751013 through speed post only.

Submission of the above documents in any other mode and beyond last date shall not be entertained .

A list of Games /Events or Tournaments to be conducted by the Council during this year is enclosed here with for reference. Match schedule , Fixture and other guidelines of the Tournaments/Events of Sports & Games will be notified in due course.

A minimum number of 08 (eight) entries are required for holding the State level Tournaments / Matches on each event. Less than 08 entries shall not be allowed (As per SGFI Rules & Regulations).
